- Farm building construction workplaces will be safe workplaces and all farm building construction workers will work in a safe work environment and be provided with all applicable Federal and Provincial protections.
- Operate your business in a manner that does not support the underground economy
- Deal fairly and honestly in all matters with customers, employees, sub-contractors, financial institutions, suppliers, professionals, colleagues and competitors.
- Refrain from the use of false or misleading advertising.
- Refrain from making false or misleading statements about competitors and their products.
- Refrain from taking on work for which a member is not competent
- Refrain from discussions or actions that may restrain competition.
- Seek appropriate compensation for services rendered.
- Stand behind all work, products or services provided in accordance with applicable contracts and warranties.
- Stay current on changes to applicable laws, regulations, safety standards, and construction standards and techniques.
